1. Contact with us: If you get in contact with us using the form on our Website or per e-mail, your data provided will be treated confidentially and be processed only for the purpose of dealing with your inquiry and in line with the pertinent legal provisions. In case of further inquiries we save your data provided for six month. We don't forward your data without your permission.

2. Our Webshop – Data storage:

For the purpose of contract processing your following data will be saved: name, postal address, e-mail address. Your data provided are necessary for fulfilment of the contract. Without this data we cannot enter into a contract with you. We don't make your data available to third persons except our shipping company responsible for the delivery, insofar as required for delivery, and our tax consultant for fulfilling our tax-based-regulations. By cancellation of purchase, no data will be saved. By conclusion of an agreement all data of the contract will be saved until the expiration date of fiscal law (seven years).

3. Data privacy:

Your data will not be stored in a Cloud. Your IP address will not be stored.

Your personal data are stored on specific protected Servers. Only few particularly authorized people have permission and access to this Server, especially those who are responsible for technical support. They take precautions for the safety of your data such as loss, damage, falsification, manipulation, unauthorized access or disclosure.

Data process is based on government regulations § 96(3) TKG and article 6(1) lit a (permission) and / or lit b (necessary for fulfilment of contract) DSGVO.

4. Use of Cookies:

Your search on our Website is not recorded by us. We do not use cookies, save any cookies and do not generate any user profiles. The saving of cookies can also be prevented with the help of your personal Browser settings.

5. Use of Web-Analytic-Tools such as e.g. Google Analytics, eTracker, etc.

We do not use any functions of a Web-Analytic Service. Savings can also be prevented with the help of your personal Browser settings.

6. Newsletter: You can subscribe to our Newsletter on our Website. For that purpose we need your E-Mail address and your approval to receive our Newsletter.

You can any time cancel this approval for receiving such e-mails by resending an e-mail to office@mathis-photographs.com. We delete your data in connection with our Newsletter immediately.

7. Your Rights:

Basically you have the rights of: disclosure, correction, cancellation, limitation, data portability, withdrawal and contradiction. You will be informed about actions we have taken, in written form and free of charge.

If you believe that the processing of your data are against: privacy law, data protection rights or infringed your rights in any manner you can complain to the regulatory authority. In Austria it is the data protection authority.

8. Social Media Plugins:

On our Website a Plugin of the Social Media Network „Facebook“ is embedded. You will recognize it on the appropriate logo or „Like-Button“. Through embedding the Plugin the Network will receive information your Browser had access to our Website, even if you don't have a profile or are not logged in. This information (including your IP-address) is reported directly from your Browser to a Server of their Network and stored there.

If you are logged in for this service, the Network will directly associate your visit to our Website to your Profile.
